Placing an order:

Estimated contract value excluding VAT: €18,500

Conditions of participation of candidates in accordance with §32 par. Article 1 (a) e) of the Act:

A. Submission of the copy or the original extract from the Commercial Register or the Trade Register (only applies to the tenderer, at the latest on the day of issuing the order / contract). The document must show the authorization to carry out the work in question.

B. The tenderer must be able to ensure that the subject-matter of the contract is carried out in full as required by the contracting authority.

Evaluation criteria

The comparative criterion for assessing the tenders submitted will be the total price excluding VAT in EUR in accordance with the applicable legislation of the Slovak Republic, which must include the price for the whole subject of the contract requested, ie. the sum / summary of all items based on the candidates' awarded items. If the prices quoted in tenders are calculated in a currency other than Euros, these tenders will be excluded from public procurement. The proposed contract price is a fixed price and is determined as the price at the time of signing the contract or issuing the order.

Bid Evaluation process

- **1.** The evaluation of tenders shall be carried out in an ascending order of all tenders not excluded from the evaluation according to the price criterion.
- 2. The first-ranked bid (i.e. the lowest bid) will be evaluated as successful (or the bidder who submitted the bid will be evaluated as successful). Other bidders will be unsuccessful in this competition. The public tender shall send the result of the evaluation of the tenders to all tenderers whose tenders were evaluated.
- **3.** The fact that the tenderer was not selected to supply the subject-matter of the contract to a public tenderer does not create a claim for compensation by the tenderer.

Let us familiarize you with the key facts of the contract being awarded

- the bid submitted in accordance with the required specifications and conditions must be confirmed by the supplier / tenderer
- the proposed contract price must be determined according to the Act of the National Council of the Slovak Republic no. 18/1996 Coll. on prices, as amended, Decree of the Ministry of Finance of the Slovak Republic no. Implementing Act no. 18/1996 Coll. on prices and in accordance with Act of the National Council of the Slovak Republic no. 222/2004 Coll. on Value Added Tax, as amended, and must include all costs associated with the implementation of the subject matter of the contract.
- the public tenderer is requesting a bid in english language
- a successful order will be sent to the successful tenderer for the performance of the subject of the contract, and the successful tenderer must also submit the originals or photocopies of the originals of the following documents before sending the order: Proof of business authorization issued in accordance with the law of the country of origin of the tenderer
